## Baseline Emissions Footprint

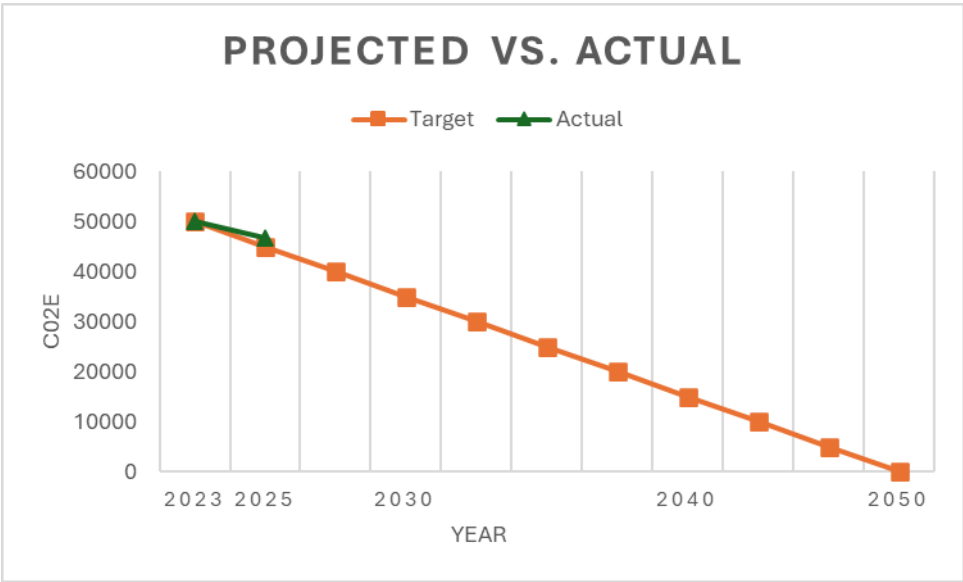

## Emissions reduction targets

Our baseline is taken from August 2022 to July 2023 and we aim to reach net zero by 2050.

We are presently on target and have reduced out C02e by 8% since establishing our baseline and project our carbon emissions will decrease over the next five years by 20%.

## **Carbon Reduction Plans.**

SCOTT Medical Ltd are ISO14001 registered and are presently as environmentally efficient onsite as possible.

As part of our plan we have investigated the investment requirements for the installation of solar panels on our roof to offset our electricity consumption presently being drawn from the national grid. We are in discussions with the property owner.

We have an ongoing plan for the replacement of our fleet and as vehicles become due for change, we are replacing them with lower Co2 emission vehicles and where feasible with electric or hybrid vehicles. Since our baseline we have replaced 40% of our fleet reducing our overall fleet emissions by 10%.

We further plan over the next few years to continue to replace the lighting in our warehouse and offices with energy efficient LED lighting.

## **Declaration and Sign Off**
